

### 7. PRESIDENTS ADDRESS

As the "peak" body representing Australian Radio Amateurs both within Australia and internationally, these objectives distil to two survival goals: 1) to lobby for and protect the spectrum access; and 2) to ensure survival though continued relevance of the hobby.

There is a challenging and large change program currently in play that involves all aspects of the Institute - attracting new amateurs, their training, assessment and qualification, all undertaken in partnership with

the clubs, including the functions undertaken in accordance with the Deed with the ACMA. All this is to achieve the objectives of the Institute.

Change in this context is about making the organisation more sustainable and future –proofing it. Moving to one that can fund development, ideas and grants, educate and training the amateurs of the future, with no single point risks and self-determination in place.

In 2017 the Board focussed on being more open and transparent with members, such as publishing board minutes and documents and consulting more widely with member.

The WIA posted a deficit for FY 2017 and the Board has already put in place measures to improve this in FY 2018. The Board is also actively making the organisation more sustainable with a longer-term focus - the 2018 budget has a high level of provisioning for a range of committed activities.

Membership numbers continue to be a concern as the Board. Membership engagement is a constant focus for the Board along with attracting new members and this will be a focus area in 2018. The Board has also introduced an Associates Program as a promotion channel to non-amateurs.

A huge thank you to over 400 Australia-wide volunteers that include assessors, learning facilitators, committee members that perform the various functions of the Institute. There are two fantastic staff members in the national office in Melbourne and we thank them.

The voluntary contribution to these activities by the WIA Nominated Training Organisation, the Assessors, Learning Facilitators and the many others at Institute and club levels all assist the Institute achieve its objectives for much less than a commercial for-profit organisation.

There were many submissions to the ACMA during the year. The Board has an excellent working relationship with the ACMA and is actively planning what the amateur radio service will look like under the new *Radiocommunications Act* and under the new service contract arrangements.

The Board is actively involved in the IARU Region 3 and ITU activities and funds its commitment to send representatives to these activities.

At the operational level the Board is actively looking to improve the processes and functions using continuous improvement principles. A ticketing system has been introduced to streamline the capture, processing and tracking of the many requests that are made to the institute.

As a volunteer based Not-for-Profit organisation, the board is always seeking the skills of members who can help extend the scope, efficiency and effectiveness of the WIA.

#### 12. GENERAL BUSINESS

### **Constitution Amendments**

### Motion

That the Wireless Institute of Australia amend its Constitution as follows: -

1. In Clause 4 INTERPRETATION in Clause 4.2 "Definitions" insert a new definition "Officer" after the definition of "Office" and before the definition of "Provisional Member" with wording as follows:

"Officer" has the same meaning given to it in Clause 29 (d) (i) of the Constitution.

All references to "officer" in the Constitution will be replaced with "Officer".

2. In Clause 7 ANNUAL SUBSCRIPTION delete Clause 7.2 "First Annual Subscriptions" so Clause 7.2 will now read:

3. In Clause 12 DIRECTORS delete Clause 12.6 "First Board" so Clause 12.6 will now read:

### **12.6 (Not Used)**

References to Clause 12.6 in the current Clause 14.1 (which will become Clause 14.2 – see point 4 below) will be removed so that the new Clause 14.2 (a) and (d) will read:

- (a) At every annual general meeting one-half of the Directors or if their number is not a whole multiple of two then the number nearest to but not exceeding one-half must retire from office provided that no Director may retain office for more than two years or after the second annual general meeting following the Director's appointment, whichever is the longer. A retiring Director must act as a Director throughout the meeting at which the Director retires. An election of Directors must take place each year.
- (d) No person except a Director retiring by rotation or a person recommended by the Directors for election is eligible for election to the office of Director at any meeting unless the person (being a Member) or some Member intending to propose the person has at least 45 days before the meeting left at the Office a notice in writing duly signed by the nominee giving the nominee's consent to nomination and signifying the nominee's candidature for the office or the intention of such Member to propose. Notice of each and every candidature must be forwarded to all Members not less than 28 days (or such lesser period as is from time to time permitted by the Corporations Act) prior to the meeting at which an election is to take place.
- 4. In Clause 14 APPOINTMENT AND REMOVAL OF DIRECTORS insert a new Clause 14.1 "Election of Directors" as follows:

#### **14.1 Election of Directors**

Election of Directors shall be conducted before each annual general meeting by postal ballot or electronic means in accordance with the WIA Ballot regulations as amended by the Board from time to time.

The current Clause 14.1 "Directors' retirement by rotation and filling of vacated offices" will now be Clause 14.2 "Directors' retirement by rotation and filling of vacated offices".

The current Clause 14.2 "Removal of Directors" will now be Clause 14.3 "Removal of Directors".

References to the current Clause 14.1 and current Clause 14.2 will be amended to refer to Clause 14.2 and Clause 14.3 respectively.

The references to "postal ballot" in now Clause 14.2 (c) will be replaced with "postal or electronic ballot".
