



WIA COMMON LICENSE to REBROADCAST WIA National News

This Common License Agreement ("License") is made between the Wireless Institute of Australia (WIA) and any individual, group, or affiliated club ("Licensee") wishing to re-broadcast the weekly WIA National News Broadcast.

1. Grant of License

The WIA National News is copyright to the Wireless Institute of Australia. The WIA grants this Common Licensee as a non-exclusive, non-transferable license to rebroadcast the weekly WIA National News Broadcast emanating from VK1WIA through Licensee's broadcast channels, including but not limited to Audio, Video, and Text.

2. Term

This Agreement shall commence on 1st July 2025. The rebroadcast of any WIA National News at any time after 31st July 2025 will indicate acceptance of the terms of this common license agreement. This agreement will remain in force until otherwise determined by the Board of the WIA.

3. Scope of Use

The Common Licensee may use the WIA News Broadcast solely for the purpose of rebroadcasting it to its audience. The Licensee shall not modify, edit, or create derivative works from the broadcast without prior written consent from the Secretary of the WIA. The Licensee shall rebroadcast in audio or video only within the limitations of that station's license and within the terms of the License Conditions Determination for that station.

4. Compensation

The WIA National News Broadcast is provided to Licensees free of charge.

5. Credits

Licensee agrees to provide proper attribution to the WIA in all rebroadcasts including the statement on common license that is produced by the WIA Broadcast team at the beginning of each broadcast

6. Ownership

The WIA retains all copyrights, title, and interest in and to the Broadcast and any associated materials. This Agreement does not grant Licensee any ownership rights.

7. Termination

The WIA may terminate this License with any individual, group or affiliated club upon Seven (7) days' written notice to that Licensee. Upon termination, the Licensee shall immediately cease all rebroadcasts of the WIA National News Broadcast on all mediums. The Licensee must apply in writing to the Secretary of the WIA if they wish to reinstate their rebroadcast under common license.

8. Indemnification

Licensee agrees to indemnify, defend, and hold harmless the WIA from any claims, damages, losses, or expenses arising out of Licensee's use of the WIA News Broadcast not in accordance with this common license, including but not limited to any claims of infringement or violation of third-party rights.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Victoria, and of the Commonwealth of Australia.

10. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, representations, or understandings.
